Purpose

To produce a text in Sinhala expressing ideas, information, feelings and opinions

Learning Requirements Highlighted.

Description of Assessment

Write an evaluative article in approximately 500 words in Sinhala for the Sinhala School educational magazine about the extent to which technology plays a positive or negative role in education today.

In your responses you should demonstrate evidence of how you:

- Convey relevant information, ideas, and opinions
- Convey appropriate detail (e.g. elaboration of ideas, justification of opinions)
- Convey information accurately and appropriately
- Coherently structure and sequence your response, observing the text type conventions.

Assessment Conditions

Task length: maximum of 500 words in Sinhala

To be completed over four weeks including some class and homework time.

Only one draft allowed

වේගයෙන් සංවර්ධනය වන නූතන තාක්ෂණය අධ්‍යාපනය කෙරෙහි සිදුකරන බලපෑම පිළිබඳව වර්තමාන සමාජය විවිධ මත පළකරයි. සමහර කොටස් මෙය අධ්‍යාපනය සඳහා අත්‍යවශ්‍ය සාධකයක් ලෙස සලකන අතර තවත් සමහරු මෙය අධ්‍යාපනයේ සහ වර්තමාන ළමා පරපුරේ විනාශය ලෙස සලකයි. මේ පිළිබඳව ස්ථී නිගමනයකට එළඹීමට පෙර මෙහි ඇති වාසි සහ අවාසි පිළිබඳව පුළුල්ව විමසා බැලීම වැදගත් වේ.

එලදායි ඉගැන්වීම් ක්‍රම හා නූතන තාක්ෂණය එකතු වූ විට දරුවන්ට අධ්‍යාපනයේ ඉතා විශිෂ්ට ප්‍රතිඵල කරා ළඟා විය හැක. **අධ්‍යාපනය කෙරෙහි තාක්ෂණයේ ඇති බලපෑම සලකා බලන විට මූලිකම සහ ප්‍රධානම බලපෑම සිදුවී ඇත්තේ පරිගණකය සහ අන්තර්ජාලයෙනි.**

පරිගණකය වැනි තාක්ෂණික මෙවලම් වල ඇති සිත් ඇදගන්නා සුළු ඉගැන්වීමේ ක්‍රම නිසා දරුවන් අධ්‍යාපනය සඳහා පෙළඹවීමක් සහ උනන්දුවක් ඇති කරයි. නවතම සොයාගැනීම් අනුව තාක්ෂණය මගින් දරුවන්ගේ ක්‍රියාකාරකම්, ධනාත්මක චින්තනය හා ඉගෙනීමට පෙළඹීම වැඩිදියුණු වී ඇති බව පෙනේ. ඉගෙනීමට දුර්වල දරුවන්, උපතින්ම මන්දමානසික දරුවන් වැනි විශේෂ අය සඳහා අධ්‍යාපන ක්‍රම රැසක් පරිගණකයෙන් හඳුන්වාදී තිබීමද එම දරුවන්ගේ ගුරුවරුන් හා දෙමව්පියන්ට විශාල සහනයකි.

Information and ideas are organised logically and coherently.

වර්තමානයේ සිසුන්ට ලෝකයේ කුමන කෙලවරක හෝ පිහිටි අධ්‍යාපනික වශයෙන් වැදගත් ස්ථානවල පැවැත්වෙන සම්මන්ත්‍රණ ආදියටද නිවසේ සිටම සහභාගීවිය හැකිය. උදාහරණ වශයෙන් නාසා ආයතනය මගින් අභ්‍යවකාශයේ සිටින ගගනගාමීන් සමඟ තොරතුරු හුවමාරු කර ගැනීමේ අවස්ථාව සිසුන්ට ලබාදී ඇත.

නූතන තාක්ෂණය භාවිතය නිසා අධ්‍යාපනය පාසල් කාලයට සීමාවී නැත. දරුවන්ට පාසල් කාලයෙන් පසු සවස් වරුවේද පාසල් නිවාඩු දිනවලද නොකඩවා අධ්‍යාපන කටයුතු කරගැනීමේ අවස්ථාව මෙමගින් සලසාදී ඇත. ඊ-මේල්, සහ ස්කයිප් තාක්ෂණය හරහා සිසුන්ට තම යහළුවන්, වැඩිහිටියන් මෙන්ම ගුරුවරුන් සමගද සම්බන්ධ වී තම ගැටළුවලට විසඳුම් ක්ෂණිකව ලබාගත හැක.

අන්තර්ජාලය මගින් ලබාදෙන තවත් වාසියක් නම් දුරස්ථ අධ්‍යාපන පහසුකමයි. මෙමගින් කෙනෙකුට ලෝකයේ ඕනෑම තැනක තිබෙන ආයතන මගින් පවත්වන අධ්‍යයන පාඨමාලා නිවසේ සිටම පහසුවෙන් සහ විශ්වාසදායක ලෙස කරගැනීමට අවස්ථාව සලසා දී ඇත. උසස් අධ්‍යාපනය ලබන සිසුන්ට දේශන මග හැරීම වැනි අවස්ථා වලදී ඒවා පරිගණකය හෝ ජංගම දුරකථනය මගින් පටිගත කරගෙන නැවත නැවත ඇසීම හා බැලීම මගින් මගහැරුණු කොටස් ඉගෙනගැනීම හා ඒවා තේරුම් ගැනීම වැනි අවස්ථා තාක්ෂණයෙන් ලැබෙන විශාල වාසියකි.

Opinions are adjusted or elaborated.

Successfully created the desired impact and interest and engages the audience.

මුද්‍රණ යන්ත්‍ර සහ ස්කෑන් යන්ත්‍ර බිහිවීමත්, ඊ-පොත් පහසු මිලට ලබා ගැනීමට සහ තොරතුරු පහසුවෙන් ගබඩා කර ගැනීමට හැකිවීමත් සමගම අධ්‍යාපන කටයුතු තවත් පහසු වී ඇත.

සිසු දරුවන්ගේ අධ්‍යාපනයට නූතන තාක්ෂණය අහිතකර ලෙස බලපා ඇති අන්දම මිලගට විග්‍රහ කර බලමු.

පරිගණකය හා අන්තර්ජාලය වැනි මෙවලම් අසීමිත හා අනවශ්‍ය ලෙස භාවිත කිරීම සහ දරුවන් එයට ඇබ්බැහි වීම නිසා සිසුන්ගේ ලිවීමේ සහ සිතීමේ හැකියාවන් මොට වී යමින් පවතී. උදාහරණයක් වශයෙන් දරුවන්ගේ අක්ෂර වින්‍යාසය, ව්‍යාකරණ දැනුම වැනි දක්ෂතා අඩුවී යමින් පවතී.

තාක්ෂණය වැරදි ලෙස භාවිත කරමින් තවෙකෙකුගේ දැනුම සොරකම් කිරීම හා විභාග වලදී වංචාකිරීම වැනි අවිධිමත් කියාද වර්තමානයේ දක්නට ලැබේ. ෆේස්බුක් වැනි වෙබ් අඩවි හරහා අනවශ්‍ය සමාජ ප්‍රශ්න ඇති වූ සහ දරුවන් නොමග ගිය අවස්ථාද, තරුණ ජීවිත අකාලයේ විනාශ වූ අවස්ථාද විටින් විට අද සමාජයේ දක්නට ලැබීම අභාග්‍යයකි.
